Daycare Policies, Procedures and Release, Waiver of Liability, Assumption of Risk and Indemnification Agreement

Please read carefully as this includes a release of liability and waiver of legal rights and deprives you of the right to sue RACC and related parties. Do not sign this agreement unless you have read it in its entirety.

In consideration for my dog being permitted to be a client at RACC for daycare or day/overnight boarding, I make the following representations and agree to all of the following policies, procedures, terms, and conditions:

1. **DAYCARE REQUIREMENTS** - My pet meets the following RACC requirements: s/he has successfully completed the Canine Behavior Interview, is four (4) months of age or older; s/he is spayed/neutered if over 7 months of age, is current on Rabies, Distemper, and Bordetella vaccinations and is in good health and free of ticks/fleas; is not aggressive or protective of toys; is attending Daycare with a quick release collar that contains an identification tag bearing the pet's name and owner's current contact information. I have completed the Daycare Application. My pet will enter and exit RACC with a leash.
2. **FOOD**- I understand that my pet will NOT be fed lunch. I may bring my pet's food, in my own container, to have before or after the daycare time.
3. **CAMERA, PHOTOS, OR VIDEO RELEASE** - I agree to allow RACC to use my pet's name, any images taken while s/he is at Daycare in any form or format, for use, at any time, in any media, marketing, advertising or promotional materials.
4. **PERSONAL PROPERTY** - I agree that RACC will not be responsible or liable for any lost, stolen or damaged property belonging to me or my pet. I also understand and agree that my pet's collar may be removed in the play area to prevent an injury to any dog.
5. **DAYCARE FEES** - I agree to pay for all daycare fees, services and products at the time I pick up my pet. I further agree to pay the cost of any check or debit card charges returned or challenges for any reason. Daycare costs \$21 per day and will be at a discounted rate of \$10 per day if scheduled during boarding.
6. **REFUNDS** - RACC's refund policy is available upon request.
7. **AGGRESSIVE DOGS** - My pet is not aggressive. Although RACC loves all dogs, I understand that aggressive dogs are not permitted to attend Daycare and that if my pet acts aggressively or exhibits unacceptable behavior s/he may be separated from the other pets. RACC will use reasonable efforts to consult parents about aggression and ways to address it, however aggressive dogs may be asked not to return to Daycare. Such determinations may be made at the sole discretion of RACC.
8. **ABANDONED DOGS** - RACC is a place where all dogs are loved, can play and play. No pet can be abandoned at RACC. I agree that I will not neglect to pick up my pet from Daycare by the time s/he is scheduled to leave without providing notification. Any pet that is left at RACC without any contact, instruction or notification from me will be considered

abandoned upon the seventh day of such notification failure. I understand that if I abandon my pet at Daycare, RACC will by default, become the legal guardian of the pet. I FULLY UNDERSTAND AND AGREE THAT IF I ABANDON MY PET AT RACC, I MAY BE UNABLE TO RETRIEVE POSSESSION OF MY PET AND WILL HAVE NO RECOURSE AGAINST RACC.

9. DUTY TO DISCLOSE - I have disclosed and shall continue to disclose on an ongoing basis, any and all medical or other conditions, including but not limited to personality concerns or behaviors that may affect, limit or prevent my pet's ability to participate in play time or otherwise attend Daycare.
10. ACCEPTANCE AND ACKNOWLEDGMENT OF DAYCARE PARTICIPATION RISK - I full attest that: There are inherent and potential risks involved with interactions between humans and dogs, as well as between dogs and other dogs, which may result in property damage or bodily injury, including but not limited to, permanent disability, sickness or death to human or dog; and there may be other risks not known to me or readily foreseeable at this time. I fully accept and assume all risks and responsibility for all risks, including, without limitation, all losses, costs and damages incurred as a result of my or my pet's participation in camp, including any veterinary expenses incurred on behalf of my pet. Sickness shall be defined to include any illness including but not limited to bordetella (kennel cough) or any other form of contagious illness.
11. VETERINARY LIABILITY AND CARE - I agree to let RACC provide or obtain medical treatment for my pet if it appears that s/he is ill, injured or exhibits any other behavior that would reasonable suggest that my pet needs medical attention. I AGREE THAT I AM FULLY RESPONSIBLE FOR THE COST OF ANY SUCH MEDICAL TREATMENT PROVIDED TO MY PET.

I hereby acknowledge and agree that all the information provided in the application is complete and accurate to the best of my knowledge. I further acknowledge and agree that I have read, understand and agree to all terms and conditions contained in Daycare Policies, Procedures and Release, Waiver of Liability, Assumption of Risk and Indemnification Agreement, as they may be amended from time to time, which are attached and fully incorporated into this application by reference. I hereby execute the Agreement for my dog, myself, representatives and assigns. I further attest that if I am not the sole owner or representative of the dog subject to this application that my signature is sufficient to enter into this Agreement for and behalf of any other owner or representative. I have signed this freely and voluntarily without any inducement, assurance or guarantee and intend it to be a complete and unconditional release of all liability.

RACC'S DOGGY PLAY GROUPS

Rules and Requirements

To ensure the health and safety of your pet and our other guests, we require that all of our clients comply with the following rules and regulations.

1. All dogs must be at least 4 months of age and older. All dogs over the age of 7 months must be spayed or neutered.
2. All dogs must have up-to-date vaccinations. Must show proof of current DHLLP (distemper), Rabies and Bordetella (kennel cough) and Canine Influenza Vaccinations.
3. Owners will need to certify that their dog(s) have not harmed or shown aggression or threatening behavior towards any person or other dog(s).
4. All dogs must have a complete, up-to-date and approved application on file prior to attending play groups. 1st day is trial day.
5. Please, do not bring personal items like bones or toys for play group. We have food/water bowls, measuring cups, treats and toys.
6. If a pet that is presented for daycare, boarding or play group is found to have fleas, it will be treated with Capstar or Frontline at the owner's expense.
7. We supply GI fiber dry food. If you would like your dog fed another diet, please bring the food marked with your pet's name.
8. All doggy daycares need to be dropped off between 7:30 a.m. to 9:00 a.m.
9. If you need us to feed your pet while here, we can do so before doggy day care starts or in the afternoon. If you would like afternoon feedings, once your pet is removed from the group they will not be permitted to re-enter.
10. If your pet can't make the scheduled day, please keep in mind that we do have a 48 hours cancellation policy. If you don't cancel before the 48 hours, you will be charged a full day of doggy day care.
11. We only have one doggie day care class room – so large and small dogs are together during playtime.
